Interview

Acceptance into MTN involves an interview of both Trainer and Trainee held, in most instances, in October at a suitable location. You will be advised of these details.

Funding

The minimum stipend for MTN Trainees is determined from time to time by the Stipends Commission of the Presbyterian Church of Queensland. Some churches elect to pay the whole stipend whilst other churches can only support the trainee with assistance from funds set aside by the Presbyterian Church of Queensland. The maximum assistance available for each trainee from the fund is \$15,000 per annum. It's important to realize subsidy funds are limited and we want to apply these where the need is greatest. To aid your training congregation's budgeting, as much as possible, we will make the aid offered for the second year consistent with the aid offered in the first year.

When will you know?

The Committee on Ministry Resourcing will endeavour to let you know the result of your application by mid November, or as soon as possible thereafter.
